



## 2022 Municipal and School Board Election: Key Dates

<p><b>Monday, May 2, 2022 to Friday, August 19, 2022</b> (MEA 31 and 33(4))</p>	<p><b>Nomination Period:</b> Nomination forms may be filed by candidates beginning Monday, May 2, 2022 and on any day thereafter prior to Nomination Day, at any time when the Clerk's Office is open (Monday to Friday, 8:00am to 4:00pm) and on Nomination Day, Friday, August 19, 2022, when nomination forms may be filed between the hours of 9:00am and 2:00pm.</p>
<p><b>Monday, May 2, 2022 to Saturday, December 31, 2022</b> (MEA 88.24)</p>	<p><b>Campaign Period:</b> The campaign period begins when a candidate has filed a nomination form and ends on December 31, 2022. Alternative time periods are in effect if the candidate withdraws the nomination, if the Clerk rejects the nomination, or the candidate extends his/her campaign and is continuing to campaign to erase a deficit.</p>
<p><b>Friday, August 19, 2022</b> (MEA 31 and 33(4))</p>	<p><b>Nomination Day:</b> Last day for filing nominations. Nominations, in the Required Form, filed on this date may only be filed between the hours of 9:00am to 2:00pm.</p>
<p><b>Monday, August 22, 2022</b> (MEA 35; 37)</p>	<p><b>Certification of Nomination Forms and Acclamations:</b> The Clerk shall certify filed nomination forms prior to 4:00pm. Immediately after 4:00pm, the Clerk shall declare any acclaimed eligible candidates to be duly elected.</p>
<p><b>Thursday, September 1, 2022</b> (MEA 23)</p>	<p><b>Voters' List:</b> The Clerk shall make the list of voters available to persons entitled. The list is for election purposes only and as such, viewing with be supervised.</p>
<p><b>Thursday, September 1, 2022 to Monday, October 24, 2022.</b></p>	<p><b>Revision to Voters' List – Application to Add, Remove, or Correct One's Own Information:</b> Individuals may make application to the Clerk requesting their name/information to be added, removed or corrected.</p>
<p><b>Monday, October 24, 2022</b></p>	<p><b>Election Day:</b> Voting opportunities will be held between the hours of 10:00am and 8:00pm. Voting locations will be published and voter notifications packages provided.</p>
<p><b>Tuesday, October 25, 2022</b></p>	<p><b>Declaration of Results:</b> The Clerk will declare the results of the election of candidates and the result of any vote upon a by-law or question "as soon as possible after voting day".</p>
<p><b>Tuesday, November 15, 2022</b></p>	<p><b>Term of Office Commences:</b> Elected members must take the oath of office prior to taking their seat. Inaugural Meeting will be held November 15, 2022 at 7:00pm.</p>
<p><b>Saturday, December 31, 2022</b></p>	<p><b>Campaign Period Ends:</b> Deadline to provide the Clerk with written notification of deficit and continuation of campaign. Candidates may file financial information.</p>
<p><b>Friday, March 31, 2023</b></p>	<p><b>Filing Date:</b> Deadline for filing financial statements by 2:00pm. Penalties for non-compliance may apply.</p>
