

# THE CORPORATION OF THE TOWNSHIP OF NORTH GLENGARRY

## BY-LAW No. 24 - 2007

**BEING** a by-law to permit the operation of All Terrain Vehicles (“ATVs”) within the Corporation of the Township of North Glengarry.

**WHEREAS** the *Highway Traffic Act*, R.S.O. 1990, Section 191.8, subsection (3) as amended, authorizes municipalities to pass by-laws permitting ATVs to be operated on highways or part of highways within the jurisdiction of the municipality and during specified hours.

**AND WHEREAS** it is deemed in the best interest to regulate, govern, and limit the operation of ATVs within the Township;

**THEREFORE** the Council of the Corporation of the Township of North Glengarry enacts as follows:

### Section 1: Definitions

#### In this By-law:

**1.1** “All Terrain Vehicles (ATVs)” means an off road vehicle that:

- a) has four (4) wheels, the tires of all of which are in contact with the ground;
- b) has steering handlebars;
- c) has a seat that is designed to be straddled by the driver;
- d) is designed to carry a driver only and no passengers; and
- e) does not include Argos, dune buggies, etc.

**1.2** “Highway” means a common and public highway, street, avenue, parkway, driveway, square, place, bridge, viaduct, or trestle, which is in within the jurisdiction of the Township, any part of which is intended for or used by the general public for the passage of vehicles and excludes green roads (as outlined on attached Schedule “B”) and unopened road allowances.

**2.** ATVs are permitted on the traveled portion of any highway within the jurisdiction of the Township.

**3.** The provisions of Sections 6 to 15 of Ontario Regulations 316-03 “Operation of Off Road Vehicles on Highways” shall apply to the operation of ATVs on highways within the Township.

**4.** ATVs shall be operated on highways only during the hours specified in Schedule “A”.

**5.** Any person who contravenes any section of this by-law is guilty of an offence and upon conviction is liable to a fine as provided in the *Provincial Offences Act*.

**6.** This by-law is to be reviewed semi-annually.

**7.** This by-law shall have full force and effect from the date of its passing.

**READ** a first, second, third time and enacted in Open Council this 26, day of March, 2007.

6:00 a.m. to 11:00 p.m.
