

**THE CORPORATION OF  
THE TOWNSHIP OF NORTH GLENGARRY  
BY-LAW #38-2009**

**BEING** a by-law to prohibit the Being at Large of Animals within The Township of North Glengarry.

**WHEREAS** section 103 of the Municipal Act, 2001, S.O, 2001, Chapter 25, authorizes a Council of a Municipality to pass a by-law prohibiting animals being at large or trespassing within the Municipality:

The council of the Township of North Glengarry hereby enacts as follows:

**PART I**

**DEFINITIONS:**

1. "Animal" shall mean any horse, bull, ox, cow, goat, sheep, pig, alpaca, llama, or other cattle, geese, chicken or other poultry.
2. "Being at Large" shall mean that an animal shall be deemed to be Being at Large when found in any other place other than lands owned or occupied by the person responsible for the charge and keeping of the animal, except where the animal is present with the permission of the owner or occupant of such place.
3. "Owner of any Animal" shall mean the owner or occupant of any land responsible for the charge and keeping of any animal.
4. "Trespassing" shall mean that an animal shall be deemed to be trespassing when found in any private property when the animal is present without the permission of the owner or occupant of such private property.

**PART II**

**ANIMALS BEING AT LARGE:**

5. Animals Being at Large or Trespassing within the Municipality is prohibited and no person who is an Owner of any Animal shall allow an animal to be at large or to trespass.
6. Every person who contravenes the provisions of this Bylaw is guilty of an offence and upon conviction is liable to:
  - a. A fine as set out in schedule "A"; or
  - b. A fine as provided for in the Provincial Offences Act R.S.O. 1990 Chapter P. 33
  - c. Where a person is convicted of an offence under this by-law, the Ontario Court of Justice or any court of competent jurisdiction thereafter may, in addition to any other penalty imposed on the person convicted, make an order prohibiting the continuation or repetition of the offence by the person convicted.
