Tenders must be submitted by email to pwdirector@northglengarry.ca on the forms provided by the Township. Hard copies will not be accepted.

Deadline for Questions: 4:00 PM, local time on: **February 16th, 2026**. Questions should be submitted to Marco Vincelli, P.Eng., Project Manager, EVB Engineering, using marco.vincelli@evbengineering.com and Adam Poapst, P.Eng., Contract Administrator, EVB Engineering. Addendums will be posted to the OneDrive and Pre-Qualified General Contractors will receive an email notifying them of the posting. It is the sole responsibility of the Bidder to ensure any addendums have been reviewed and are included with the Tender submission. If addendums are not included with submissions, bids may be rejected.

Deadline for Submissions: 11:00 AM, local time on: **February 24th, 2026**.

Bids will be opened on February 24th, 2026, immediately following the closing deadline.

Bids received after the deadline will be rejected.

The Township reserves the right to reject any or all submissions, as a whole or in parts, and waive formalities in the best interest of the Township, without stating reasons. The Township reserves the right to terminate a Tender process at any time, without stating reasons. The Township reserves the right not to accept the lowest Tender.

All Bids received will be held in strict confidence until after the closing date and time.

All information required in the Tender forms, in connection with each item against which a Tender is submitted, must be given to constitute a valid Tender.

The work at the site consists of:

- Construction of a new Operations Building, including all architectural, civil, structural, mechanical, electrical, instrumentation and process elements as defined within the contract documents.
- Installation of aeration supply piping, aeration grids and interbasin baffle curtains in Cells A, B, and D.
- Construction of supporting structures, including but not limited to the following: intermediate pump station, SAGR influent control chamber, effluent level control structures, air piping, electrical cabling & conduit, upgrade of existing chemical storage building, etc.
- Demolition of the following: mechanical aerators in Cell A, existing alum building, existing chlorine contact channel, and other structures as shown on the drawings.
- Coordination and connection of the new filter effluent to the outfall ditch.
- Work covered by the contract documents includes Construction of, and Commissioning of the facility as per Section 01 91 13 – Commissioning (Cx) and Division 01 contract documentation requirements.

There will be a mandatory job showing at the site on **February 3rd, 2026, at 10:00am**. The site is located at 20596 McCormick Road, Alexandria, ON.
