**NOTICE OF PUBLIC MEETING  
CONCERNING A PROPOSED AMENDMENT  
TO THE TOWNSHIP OF NORTH GLENGARRY  
ZONING BY-LAW No. 39-2000**

**TAKE NOTICE** that the Council of the Corporation of the Township of North Glengarry will hold a public meeting of planning on the 22nd day of June 2026 at 5:30 p.m. in the Municipal Council Chamber, located at 3720 County Road 34, Alexandria, to consider a proposed amendment to the Township's Comprehensive Zoning By-law under Section 34 of the Planning Act as amended.

**THE PURPOSE** of the Zoning By-Law Amendment is to re-zone the property from General Agricultural Special Exception 180 (AG-180) to General Agricultural Special Exception 284 (AG-284) to permit a secondary dwelling, as defined in the Ontario Building Code, on the subject lands.

**IF YOU WISH TO BE NOTIFIED** of the decision of the Council of the Township of North Glengarry on the proposed zoning by-law amendment, you must make a written request to the Township of North Glengarry, 3720 County Road 34, Alexandria, ON, K0C 1A0, Attention: Jacob Rheume (Director of Building, By-law & Planning) or by email at [jacob@northglengarry.ca](mailto:jacob@northglengarry.ca).

*If a person or public body would otherwise have an ability to appeal the decision of the Council of the Township of North Glengarry to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of North Glengarry before the by-law is passed, the person or public body is not entitled to appeal the decision.*

*If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of North Glengarry before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.*
